

CONDITIONS

Cost-share:

The Well Head Remediation & Dormant Well Project program cost-share will be 50% SRRWD, 50% Landowner with a maximum SRRWD contribution of \$500.

The annual projects resulting from this program are subject to available annual funding. The SRRWD will determine application priorities on a first-come, first serve basis. All projects must be approved by the SRRWD Board prior to construction and/or installation.

The Landowner shall:

1. Keep track of in-kind contributions made in order to complete the project;
2. Not alter, change, remove, or modify the project without written consent of the District;
3. Indemnify and save harmless the Seine Rat Roseau Watershed District from any and all actions, claims, suits, damages, injuries or other loss no matter how arising as a result of the construction, operation, or maintenance of this project.
4. Perform any necessary maintenance following the completion of the project.

The Seine Rat Roseau Watershed District shall:

1. Approve all applications prior to construction. A sub-district member, the sub-district chair and a staff member will conduct a preliminary site visit and approve the project on behalf of the sub-district, then recommend the project to the board for approval;
2. Reimburse the landowner once the project has been completed, receipts are submitted and the project has received a successful final inspection by SRRWD staff.
