General Tree Planting Information

- Keep all trees cool until planted and keep seedlings moist
- Cuttings should be stored in the refrigerator in a plastic bag and soaked for 24 to 48 hours prior to planting
- Prepare the soil; soil should be tilled to a depth of 30cm to ensure a suitable rooting environment
- Place the trees in the holes and lightly pack the soil around the tree after planting
- Water the trees well for the first week and throughout the growing season; keep the area weed free and **do not** fertilize seedlings within the first year of planting

Terms and Conditions

The planting site must be within the boundaries Seine Rat Roseau Watershed District which includes:
Entire Municipality of: RM of Stuartburn, RM of Emerson Franklin, RM of LaBroquerie, RM of Hanover, City of Steinbach, RM of De Salaberry, Village of St. Pierre, Town of Ste. Anne, and Town of Niverville
Part of Municipality of: RM of Montcalm, RM of Ritchot, RM of Taché, RM of Reynolds, RM of Piney, RM of Springfield, RM of Ste. Anne and RM of Morris

- The landowner is responsible for preparing the site, planting the trees and all maintenance of the trees and site. **(SRRWD does not provide warranty on tree seedlings and cuttings)**
- The applicant will indemnify and save harmless the SRRWD from any and all actions, claims, suits, damages, injuries, or other loss no matter howsoever arising as a result of the construction, operation or maintenance of the project.
- **Orders will be taken on first come, first serve basis;** due to the nature of the tree business there may be instances where SRRWD is unable to supply the order requested. In these instances, the applicant will be able to pick a substitution if available
- Tree pickup will be at the SRRWD Office located in Steinbach
- Any trees not picked up on the pickup date will revert to the property of SRRWD unless prior arrangements have been made
- SRRWD reserves the right for reasonable access to the project site for inspection and to promote the program
